- Print the Lifetime License Application form.
- The applicant must qualify and supply proof of Virginia residency to buy a resident license. This license is valid for the lifetime of the license holder even if the license holder becomes a nonresident of the Commonwealth subsequent to the purchase of the license. The Agency will accept as proof of residency one of the following: a copy of a valid Virginia driver's license, a valid Virginia DMV identification card or a Virginia voter registration card. For individuals purchasing a Junior Lifetime Hunting License, please enclose a letter from the parents, guardian, or grandparents attesting that the child is a Virginia resident.
- All Non Resident applicants must provide proof of identity. Enclose a copy of your driver's license or State ID. (**Send a copy only. Do not send originals.**)
- All applicants must provide proof of age by including a copy of their valid driver's license, State ID card, or birth certificate. (**Send a copy only. Do not send originals.**)
- All applicants must meet Hunter Education requirements if applying for a lifetime hunting license. (Not applicable for Junior Lifetime Hunting License – see below.) Persons under the age of sixteen receiving a hunting license must submit a copy of their Hunter Education Certificate with the application.
- The Junior Lifetime Hunting License will be valid for hunting when a child is accompanied and directly supervised by a properly licensed adult. Upon the child's 12<sup>th</sup> birthday, this license shall become invalid and shall remain invalid until certification of competence in hunter education is received. Send a copy of the Junior Lifetime License and a copy of the Hunter Education Certificate with a note requesting a permanent license (include corrected address if needed) to DGIF's Richmond Office. A permanent Lifetime license will be reissued at no cost.
- All lifetime licensees are required to obtain all additional state and local licenses, permits and stamps as required by law. See the [hunting](#) and [fishing](#) regulations which are available where licenses are sold or on our web site at [www.dgif.virginia.gov](http://www.dgif.virginia.gov).
- Select the license(s) you wish to purchase.
- Check that you have **copies** of all required documents.
- Sign and date the application. The application must be signed by the applicant or by the person certifying the application on behalf of the applicant.
- If purchasing this license as a gift or certifying information on behalf of an applicant, complete the [Certification of Applicant](#) and include all required documentation.
- Include a **PERSONAL CHECK, MONEY ORDER or CASHIER'S CHECK** made payable to the **TREASURER OF VIRGINIA** or pay using **VISA/MASTERCARD** by filling out the credit card authorization form below. Return this application with all supporting documents and payment to:
