Instructions:

- 1) Fill out the Lifetime Virginia Boater Education Card application on the next page.
- 2) The applicant must qualify and supply proof of boater safety education course completion. To show proof of successful completion of a NASBLA approved boating safety course, a copy of your course completion certificate or wallet card should be included. If you do not have a copy of your course completion card, contact the course provider to get a copy of the course completion. If you took a DGIF sponsored "Boat Virginia" classroom course, you may check that box on the application and we will look up the information in our database. If you cannot supply an end of course completion certificate or wallet card or your name is not in our database, we will not be able to issue you a card. This card is valid for the lifetime of the license holder.
- 3) Check that you have copies of all required documents
- 4) Sign and date the application. The application must be signed by the applicant or by the person certifying the application on behalf of the applicant.
