TEMPORARY SUPPLEMENTAL LICENSE

New watercraft dealers, used watercraft dealers, manufacturers, factory branches, distributors, distributor branches and wholesalers may be issued a temporary supplemental license, for a period not to exceed fourteen days, to display for sale or sell watercraft at a show.

Application for temporary supplemental license must specify the location to be occupied by the licensee in conducting such business. The temporary supplemental license must be conspicuously displayed on each of such premises.

The fee for each supplemental license is twenty-five dollars (\$25.00)
