

**The Virginia Migratory Waterfowl Conservation Stamp
and
Virginia Ducks Unlimited Conservation Print
Program**

2016 Artist Competition Agreement

The undersigned, hereinafter referred to as the "Artist", hereby submits to Virginia Ducks Unlimited, Inc., hereinafter referred to as "VADU", the enclosed original artwork for competition in the 2016 Virginia Migratory Waterfowl Conservation Stamp and Virginia Ducks Unlimited Conservation Print Program. This competition will select a single piece of flat-art, to be reproduced as the 2016 Virginia Migratory Waterfowl Conservation Stamp and the 2016 VADU Migratory Waterfowl Conservation Stamp Print. The following stipend will be awarded:

The winning Artist will receive compensation of two-thousand and five hundred dollars (\$2,500.00) payable from VADU.

Artist further agrees and acknowledges that:

1. The Artist attests that this submission is his original work and has not been reproduced, printed or copied in previous editions.
2. The winning submissions will become the property of VADU. VADU shall be authorized to sell, distribute, display, retain, or otherwise use or dispose of said artwork at its discretion.
3. Within fifteen (15) days of notification of being selected as the 2016 Virginia Migratory Waterfowl Conservation Stamp and VADU Conservation Print Artist of the Year, the Artist shall sign an agreement assigning and transferring to VADU all of his/her copyright rights in the winning art.
4. Within fifteen (15) days of notification of selection, VADU will be provided a high-resolution digital image of the original artwork provided at Artist's expense in a manner appropriate for the high-quality reproduction of the image on the 2016 Virginia Migratory Waterfowl Conservation Stamp.
5. By July 1st, 2016, VADU will be provided thirty-five (35) high-quality copies of the original artwork prominently titled as "Conservation Edition" provided at Artist's expense in a manner mutually agreeable to both parties.
6. By July 1st, 2016, Artist will sign and number the Conservation Edition copies provided to VADU by Artist at no expense to VADU.

7. By July 1st, 2016, Artist further agrees to remark VADU's Conservation Edition prints for \$30 per remarque.
8. Artist agrees to provide thirty-five (35) signed stamps at no cost to VADU.
9. Artist may market Artist's prints and other merchandise displaying the original artwork image immediately after execution of Artist's Assignment without any further waiting period. Artist acknowledges that VADU is not responsible for marketing availability of prints or Artist's selection as the winner of the Program. VADU agrees to cooperate with Artist to support any reasonable marketing activities that are mutually agreed to by both parties.
